#### TAKE NOTICE THAT:

- On May 2, 2025, by an Order of the Honourable J. Dietrich of the Ontario Superior Court of Justice (Commercial List) (the "Appointment Order"), pursuant to subsection 37 of the *Mortgage Brokerages, Lenders and Administrators Act*, S.O. 2006, c.29, as amended (the "MBLA") and section 101 of the *Court of Justice Act*, R.S.O. 1990, c. C.43, as amended (the "CJA"), B. Riley Farber Inc. was appointed as receiver (the "Receiver") without security of all the assets, undertakings and properties of Sussman Mortgage Funding Inc., 2486976 Ontario Inc. and 1981361 Ontario Inc. (collectively, the "Debtors") acquired for, or used in relation to, businesses carried on by the Debtors, including all proceeds thereof (the "Property").
